Grants may support a broad range of community needs including, but not limited to health and wellness, education, the great outdoors, arts and culture, and community development. Typical grant awards range from \$1,000 - \$5000.

Grant applications must be submitted online by **5:00 PM on Monday, September 9, 2024**. Please review **GHCF's Annual Grant Guidelines** to determine your organization's eligibility **before applying**.

- 3. **Required Grant Report:** A grant report is due within one year of the grant award date. Grant reports are submitted online. All due dates, grant agreements, and grant reports are found within the online grants system.
- 4. **Overdue Grant Report(s):** If you are a grantee and have any overdue grant reports for previous grant awards from GHCF or ACF, you must complete a final grant report for those previous awards before your organization is eligible to be considered for any current or future grant opportunities from GHCF and/or ACF.
